**TICKET PRICES** – 10% Off Full Day Adult and Youth Lift Tickets.

**TICKET RESALE IS PROHIBITED** – Tickets should only be sold to employees of your corporation/organization. Employees may purchase discounted tickets for themselves, other employees, and their immediate family members only. *Any tickets that are resold or issued to non-employees may be considered a breach of this agreement and may result in the termination of this agreement.*

**PURCHASING TICKET VOUCHERS** – Employees and immediate family members can purchase lift tickets on our website [www.ski49n.com](http://www.ski49n.com) and receive this discount by entering your designated Coupon Code before checking out. Payment for lift tickets will be automatically sent to 49° North. After purchase is made, employees will receive an email receipt with a barcode that they will need to exchange at the Ticket Office for a lift ticket on the day of their visit.

**VISITING 49° NORTH** – Proof of purchase must be presented to the 49° North ticket window in exchange for a lift ticket on day of visit. Discounted Corporate Tickets will not be sold at the ticket window. Tickets are valid during the 2022-2023 winter season only, expire March 31, 2023, and are non-refundable.
